Subject: Complaint regarding Amy Ockerlander PDC Case 34603

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed against Amy Ockerlander, a 2017 candidate City of Duvall Mayor. The complaint alleged Amy Ockerlander (Friends of Amy O) violated RCW 42.17A.235 and .240 by failing to timely file complete and accurate Monetary Contribution reports (C-3 reports) and Summary Full Campaign Contributions and Expenditure reports (C-4 reports).

PDC staff reviewed the allegations listed in the complaint, PDC laws, rules and reporting requirements, the Candidate Registration (C-1 report), C-3 and C-4 reports filed by Amy Ockerlander.

Based on staff's review, we found the following:

- On Feb. 1, 2017, Amy Ockerlander filed a C-1 report declaring candidacy for City of Duvall Mayor, selecting the Mini Reporting option, and listing herself as Treasurer.
- On June 21, 2017, Amy Ockerlander filed 15 C-3 reports, covering Feb. 15 – June 16. On June 22, 2017, she filed a C-3 for a deposit made on June 20, 2017.
- On June 22, 2017, Amy Ockerlander requested to change from Mini to Full Reporting. This request was approved by Peter Lavallee, Executive Director of the PDC, on July 6, 2017.
- Amy Ockerlander then filed numerous C-3 and C-4 reports in July 2017. On Aug. 10, she filed a C-4 covering July.
- As of August 2018, Amy Ockerlander was in compliance with Full Reporting, filing her C-3 and C-4 reports timely.
- The Campaign timely filed the 21-Day Pre-General Election C-4 report on October 17, 2017, and the 7-Day Pre-General Election C-4 report on Oct. 31, 2017. There was no 2017 primary election for City of Duval Mayor.

Based on this information, the PDC has dismissed this matter in accordance with RCW 42.17A.755(1) and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.

In addition, the PDC has also dismissed the allegations listed in your complaints that were based “on information and belief” in accordance with RCW 42.17A.755(1), since you failed to provide any evidence to support or substantiate those allegations.
